

WHEREAS there are no revenue bond ordinance or other ordinances or resolution of the municipality which require financial statements and financial reports to be prepared in conformity with K.S.A. 75-1120a (a) for the year ended December 31, 2012.

NOW, THEREFORE BE IT RESOLVED, by Jackson County, Kansas, in regular meeting duly assembled this 14th day of January 2013 that Jackson County Commissioners request the Director of Accounts and Reports to waive the requirement of K.S.A. 75-1120a (a) as they apply to Jackson County for the year ended December 31, 2012.

BE IT FURTHER RESOLVED that the Jackson County Commission shall cause the financial statements and financial reports of Jackson County to be prepared on the basis of cash receipts and disbursements as adjusted to show compliance with the cash basis and budget laws of this State.


