

RECISSION OF INTERLOCAL COOPERATION AGREEMENT

WHEREAS, in 2007 the Boards of Commissioners of the Kansas counties of Doniphan, Atchison, Brown and Jackson created the Northeast Kansas Regional Household Hazardous Waste Program through execution of an INTERLOCAL COOPERATION AGREEMENT; and

WHEREAS, said INTERLOCAL COOPERATION AGREEMENT has served the member counties well, reducing costs and increasing safety to the public and the environment; and

WHEREAS, recent changes have made clear that continued operation of the Northeast Kansas Regional Household Hazardous Waste Program are impractical, with Brown County having given its notice of intent to withdraw effective at the end of this calendar year, and Doniphan County having given notice of intent to withdraw at the earliest possible date; and

WHEREAS, pursuant to section 7.2 of the INTERLOCAL COOPERATION AGREEMENT, upon the withdrawal of a County from the program, the agreement would continue in effect unless determined otherwise by a majority of the remaining parties; and


WHEREAS, a majority of the remaining parties now determine to disband the Northeast Kansas Regional Household Hazardous Waste Program and withdraw from the INTERLOCAL COOPERATION AGREEMENT.

NOW THEREFORE, BE IT RESOLVED BY THE Board of Directors that the Northeast Kansas Regional Household Hazardous Waste Program is dissolved effective October 22, 2014.

BE IT FURTHER RESOLVED THAT any personal property which has been acquired pursuant to the interlocal agreement shall remain the property of the individual counties, all as set forth in said INTERLOCAL COOPERATION AGREEMENT.

RESOLVED THIS 22nd day of October, 2014 by the Board of Directors of the Northeast Kansas Regional Household Hazardous Waste Program.




