WHEREAS there are no revenue bond ordinance or other ordinances or resolution of the municipality which require financial statements and financial reports to be prepared in conformity with K.S.A. 75-1120a (a) for the year ended December 31, 2017.

NOW, THEREFORE BE IT RESOLVED, by Jackson County, Kansas, in regular meeting duly assembled this 9th day of January 2017 that Jackson County Commissioners request the Director of Accounts and Reports to waive the requirement of K.S.A. 75-1120a (a) as they apply to Jackson County for the year ended December 31, 2017.




